

The project is the extension of the existing Kempinski Hotel with an area of 12,500m².

The project works included the following:

- 1. Demolishing and dismantling of salvageable items.
- 2. Civil and skeleton works.
- 3. Finishing works.
- 4. Mechanical and electrical works.
- 5. Specialized works for the ID, AV, Façade cladding.
- 6. Lighting and kitchen equipment.
- 7. Demolishing and reconstruction works inside the existing hotel with all necessary safety measures.

Morganti | CCC-CM completed this project without any disruption to the operation of the existing hotel.





TAJJ Mall is a wide commercial project developed on a 22,900m² land with a built up area of 150,000m². The Mall hosts a wide spectrum of tenants, including cinemas, bowling alleys, advanced areade area, retail outlets, food courts, kids' zones, restaurants and cafes. The new total built-up area is approximately 20,000m².


